## CASC RCM Report February

2/08/2025

Good afternoon CASC,

I attended the most recent RSC meeting on Saturday 1/25.

There is a possibility that I will be unable to attend the next RSC which will be held Sat March 15<sup>th</sup> at 1 PM; at St. David's Episcopal Church, 90 South Main Street, Cranbury, NJ 08512. I will not know for sure until Friday Feb. 14 if I will be required to work on that Saturday. If I do have to work, I will do my best to still attend Region late to pickup meeting directories if the Area purchases them. As soon as my employer lets me know, I will let the Area know.

I attended the Mid Atlantic Regional Learning Conference from Jan 17-19 in Lancaster, PA. I participated in workshops on current World Service Conference Issue Discussion Topics including "Gender Neutral and Inclusive Language in NA Literature" and "Disruptive and Predatory Behavior". I also was present at the Interim CAR Workshop hosted by World Board members and WSC Co-Facilitators. I will be submitting receipts to the CASC for reimbursement of \$395.98. The early registration room rate was \$187.59 per night (x2 nights) and the basic early registration fee was \$20.80.

During the Interim WSC Workshop, the twelve interim motions were explained and discussed at length. At the RSC on 1/25, it was the conscience of the NJ Region to bring two of these motions back to Areas and Groups for a vote. I sent an e-mail on Saturday 2/1 to the current list of recipients on the most recent CASC Minutes list. As stated in this e-mail, motions from the Interim WSC would not normally be brought back to groups before the Regional Delegate votes on behalf of our Region, which is why our Groups were left with such little time and limited information before discussing these two motions. If the CASC would like me to provide the Regional Delegate with our Areas conscience, I believe a GSR will have to make a motion during new business to have all present GSRs provide their Groups conscience, if they were able to come to one on these motions.

**Motion 1:** *To adopt for the 2025 Interim WSC and the 2026 WSC only: If a motion has consensus in an initial straw poll (that's 80% or more in support or not in support), the Cofacilitators will announce the results as a final decision. Intent: To minimize time spent addressing items the conference already has agreement on.*

In summary, the WSC has been transitioning from unanimous based decision making to a consensus based body and this motion reflects that change.

The NJ Region expressed that this motion should be brought back to groups to come to a conscience especially considering our ninth concept of NA service "*All elements of our service structure have the responsibility to carefully consider all viewpoints in their decision-making processes.*"

**Motion 5:** *To adopt for the current conference cycle only: The 2026 WSC will take a new step in Strategic Planning by using a revised process (described below) for the CAR survey to consider ideas for recovery literature, service material, and Issue Discussion Topics. Instead of submitting motions for project plans to create specific pieces of service material, recovery literature or IDTs for the 2026 Conference Agenda Report, conference participants will submit those ideas for possible inclusion in the 2026 CAR survey. Intent: To implement a process for all conference participants to collaboratively create a CAR survey with all ideas for Fellowship consideration of literature, service materials, and Issue Discussion Topics.*

In summary, currently, when the conference passes a motion to create a project plan for a specific piece of literature, that idea gets included in the CAR survey for potential prioritization by the conference. If Motion #5 were to pass, those ideas would go directly into the CAR survey rather than being included in the CAR as separate motions. The revised process keeps the doors open for all NA members to submit ideas but gives conference participants the ability to create a more manageable final draft of the CAR survey.

The NJ Region expressed that this motion should be brought back to groups as it relates to the selection of ideas for future fellowship literature and service material.

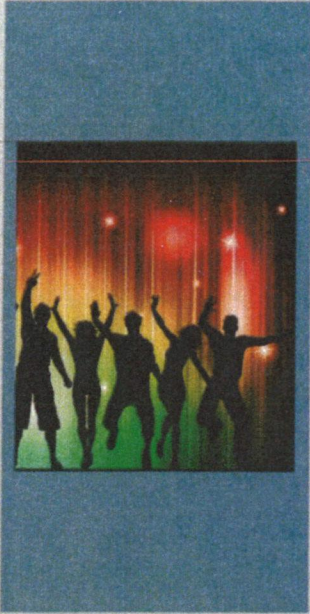

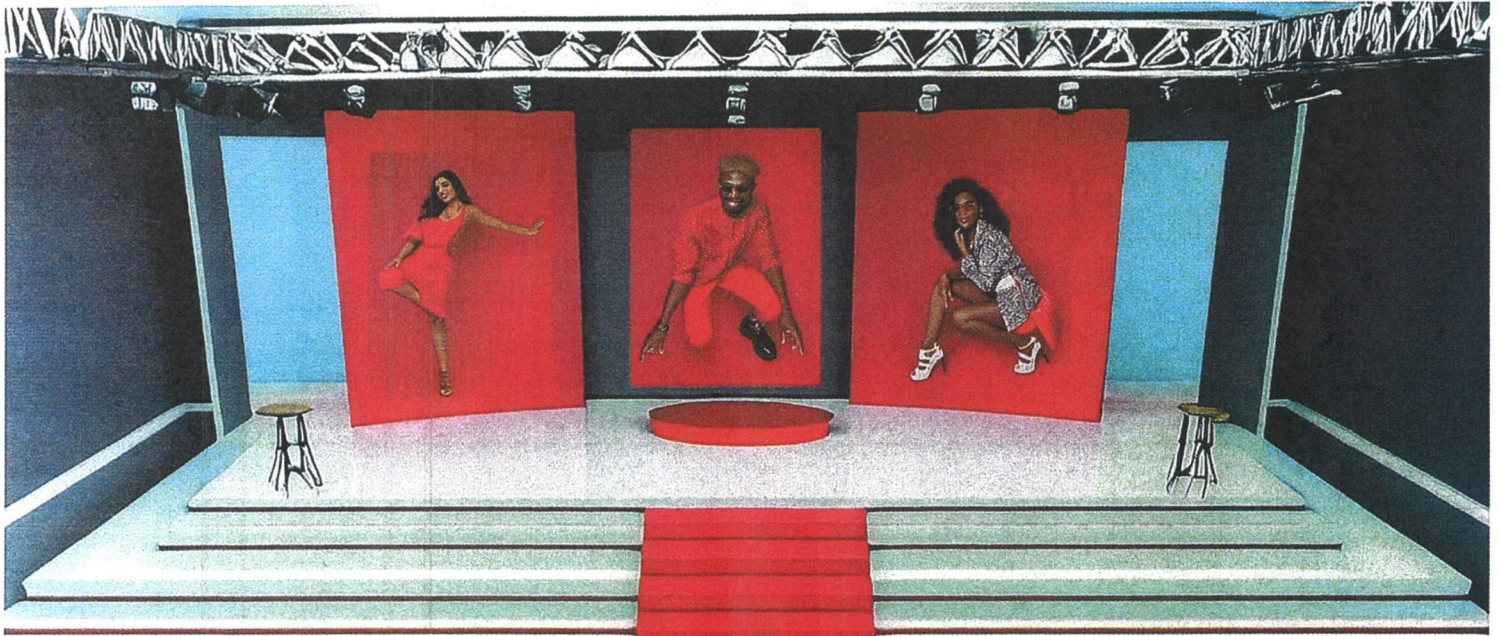

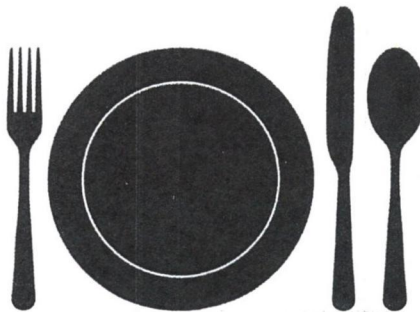
